I write on behalf of the Division of Rate Counsel in support of \$1880 (Requires lowest possible price not exceeding certain cap for inmate telephone calls.). I regret I am unable to attend the committee's meeting on May 23, 2016, but I hope you will consider our comments. Attached is a letter we sent in January, 2016 to the Assembly sponsors supporting the companion to S1880. We continue to support this legislation.

As you are aware, Rate Counsel represents and protects the interests of all utility customers - residential customers, small business customers, small and large industrial customers, schools, libraries, and other institutions in our communities. Rate Counsel is a party in cases where New Jersey utilities seek changes in their rates or services. The lack of regulation over prison calling plans led to non-competitive, non-cost-based bidding resulting in an inequitable burden and expense on vulnerable telephone consumers. Rate Counsel's Letter In Support of A4576 / S1771 Bill Which Amends Title 30 of the Revised Statutes by Requiring the Lowest Possible Price not Exceeding a Certain Cap for Intrastate Inmate Telephone Calls

Dear Assemblymen Johnson and Wimberly and Senators Turner and Weinberg:

The Division of Rate Counsel ("Rate Counsel") writes in support of the adoption of S1771/A4576 which will reform inmate calling rates to ensure that the rates paid are just and reasonable. Rate Counsel notes that the lack of regulation in this area has incentivized non-competitive, non-cost-based bidding resulting in an inequitable burden and expense on vulnerable telephone consumers.

As you are aware, Rate Counsel represents and protects the interests of all utility customers — residential customers, small business customers, small and large industrial customers, schools, libraries, and other institutions in our communities. Rate Counsel is a party in cases where New Jersey utilities seek changes in their rates or services. Rate Counsel also gives consumers a voice in setting energy, water, and telecommunications policy that will affect the rendering of utility services well into the future.

The passage of this legislation will end the longstanding practice employed by private and public institutions throughout the state that choose to contract for higher rates in exchange for commissions and/or other add-on fees imposed by inmate calling service (ICS) providers. Rate Counsel commends the efforts of the sponsors to close the loopholes that exist and resolve this serious problem through passage of this legislation. As noted by some commenters throughout the State, the ability to maintain contact with loved ones and friends throughout an inmates' incarceration is vital and plays a critical role in an inmate's or detainee's ability to reintegrate into society. Rate Counsel further notes that this legislation is also consistent with

recent rules adopted by the Federal Communications Commission. Accordingly, Rate Counsel supports this legislation and urges the Legislature to proceed with the adoption of S1771/A4576 as soon as possible so that inmates, detainees, their families, and friends are only charged just and reasonable rates for telephone calls.
